MULTIPLE ROCKET LAUNCHES USING ROCKETS OF VARIOUS SIZES NOT TO EXCEED 4100 FEET MSL.

ALTITUDE: Surface to 4100 FEET MSL (2500 FEET AGL)

4. This certificate is nontransferable.


NOTE-This certificate constitutes a waiver of those Federal rules or regulations specifically referred to above. It does not constitute a waiver of any state law or local ordinance.

SPECIAL PROVISIONS

1. Mr. Bruce S. Levison, hereinafter referred to as Launch Manager, shall retain sole responsibility for ensuring safety of this event. This includes safeguarding persons and property on the ground, as well as, aircraft in the vicinity of the rocket launch site.
2. The Launch Manager shall comply with all pertinent sections of FAR 101 that deal with launching model rockets, except for those specific requirements that have been waived by this document.
3. The Launch Manager shall station spotters to monitor all quadrants and terminate the rocket launch any time an aircraft might traverse the operation area.

NOTE: We emphasize the safety of non-participating aviation is in the hands of your spotter and range safety officer.

4. The Launch Manager shall notify Cleveland Automated Flight Service Station (AFSS) not less than three hours and not more than 72 hours prior to beginning launch activities. This notification will ensure that a Notice to Airmen (NOTAM), detailing date, time, altitudes, type of activity, and duration will be issued. Cleveland AFSS telephone number is 216-267-5949. Format for the NOTAM shall be as follows: CLE VWV UNMANNED ROCKETS 1NMR ACO280011 3400/BLW WEF 1119071200 - 1119071530.
5. The Launch Manager shall notify Akron-Canton Air Traffic Control Tower (ATCT) one hour prior to commencing operations and immediately following the final launch of the day. The Akron-Canton ATCT phone number is 330-492-3828.
6. Altitudes to be utilized at this site will normally include the surface to 4100 feet MSL (2500 feet AGL). Issuance of this waiver does not provide sterile airspace for launch operations.
7. This waiver disposes of the Federal Aviation Administration interest in this matter but should not be construed as superseding or invalidating any existing rules or regulations promulgated by any other federal, state, county, or municipal government, which may be required for this display.
